### ... Finance Imperatives

#### Align strategy

The CFO's agenda and objectives have to be closely aligned with those of the CEO

#### **Transform operating models**

As companies look to drive organic/inorganic growth, flexible operating models are key

#### Manage performance

CFOs are well positioned to be more forward-looking and have a holistic view of performance

### **Develop finance capability**

Expectations to pivot from purely finance/accounting skills, to expertise in particular geographies/industries, and the ability to communicate and collaborate effectively across regions.

### **Embrace Digital**

CFOs need "to speak" digital so they can properly assess ROI of investing in digital across enterprise

# S/4HANA Finance: a strong enabler

# S/4HANA Finance is a *strong enabler* reinventing the role and future of ERP platform. A key support to High Velocity Finance



### Simplified data model

- Universal journal entry (one FI / CO logical document)
- Low memory consumption; no totals or index tables used
- Drill-down to line item significantly faster



### Intuitive UI

- Instant and mobile access (SAP Fiori)
- Real-time dashboards and drilldown
- End users configure reports (instead of relying on IT)



### Improved flexibility

- Enables new reporting dimensions (account based CO-PA)
- Eliminates manual reconciliation
- In-process improvement related KPIs (DSO, ME close, allocations)



### **Enhanced functionality**

- Integrated planning and predictive forecasting for P&L and liquidity
- Central finance architecture single source of truth
- Advanced cash management



# S/4HANA Finance: "brand new" simplified and enhanced data model, significantly extended functionalities powered by HANA in-memory DB engine



### Financial accounting

- Universal Journal for a single document for financial and controlling accounting data
- All general ledger data in one repository with multiple business dimensions (e.g. customers, products)
- Ledger extensions (alternate and enhancement ledgers)
- Postings to a common account, extended by dimensions for profitability analysis
- Extended foreign currency capabilities
- GL account and cost element master data is unified.
- · Financial reporting capabilities with simplified user interface

### Management accounting

- Closing and reporting processes in profitability and cost analysis are based on line items
- Account-based CO-PA is enhanced, cost-based CO-PA is NOT simplified
- Complex calculations performed at the period close are pushed down to the SAP HANA database (e.g. WIP).
- Adjusted data selection for overhead calculation and settlements in order to take advantage of full in-memory capabilities
- No more settlement runs for CO-PA derivation required. It will happen real time during posting

### Cash management

- Simple cash management solution
- Central management of cash, liquidity, review processes
- Central management of bank data
- Real-time insight in cash distribution without batch jobs
- Short-term investment or funding decisions based on current cash position and short-term cash forecast report
- Cash flow and liquidity forecast powered by SAP HANA
- Credit and Dispute Management enhanced functionalities

### **BPC** optimized

- Real-time integration of actuals with plan/forecast data
- Embedded real-time consolidation functionality\*
- Embedded liquidity planning and P&L planning on all available dimensions (e.g. cost center, internal orders, projects, market segment, profit center, functional areas)
- P&L planning top-down (e.g. target revenue breakdown) and bottom-up (cost center aggregation)
- Microsoft Excel front-end access to planning data on HANAoptimized real-time info cube

S/4HANA Finance can be introduced in complex, multi-SAP instances organizations to anticipate accounting model harmonization leveraging Central Finance suite
